

PETITION FOR RECALL

TO THE HONORABLE MEMBERS OF THE CUPERTINO UNION SCHOOL DISTRICT GOVERNING BOARD, Pursuant to the California Constitution and California election laws, we the undersigned registered and qualified electors of the Cupertino Union School District of Santa Clara County, California, respectfully state that we seek the recall and removal of Lorien Cunningham, holding the office of Governing Board Member, in Cupertino Union School District, in Santa Clara County, California. We demand an election of a successor to that office.

The following Notice of Intention to Circulate Recall Petition to the Honorable Lorien Cunningham was served on October 18, 2021:

Pursuant to Section 11020 of the California Elections Code, the undersigned, registered qualified voters of Cupertino Union School District, in Santa Clara County, in the State of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from the office of Board of Trustees, in Cupertino Union School District, Santa Clara County, California, and to demand election of a successor in that office. The grounds for the proposal recall are as follows: Lori is closing schools and your school is next. When Lori disagrees, she reminds you that you are a minion. When in a corner, she sheds crocodile tears. She says the community doesn't stand up for her. Did Lori stand up to Kai Brown, CUSD Union President, when he called 7,000+ parents bullies? Did Lori stand up when a child was wetting their bed due to her decisions? Did Lori stand up when a child was admitted for suicide by her actions? Did Lori stand up when she asked Measure A activists to spend thousands of hours to campaign while knowing that it'd fail? Lori doesn't stand up for kids. She can't because she is 100% financed by the teachers' union. Lori caused the steepest enrollment decline in history. Lori failed a parcel twice wasting \$2M in special elections. Lori closed your schools and will close more. Lori sows division and blames you. Lori plays the victim while other Board members work. Lori giddily takes union money and puts your kids second. Lori is the reason this community is divided. There is no doubt. Vote YES for decency and community. Vote YES to recall Lori!

The answer of the officer sought to be recalled is as follows:

Warning: The Proponent's Recall Statement is blatantly false and misleading. Refuse to sign. This unwarranted recall effort will cost taxpayers \$1,000,000. In 2018 voters elected me as their first choice, by a wide margin. Since then, I have faced the hardest challenges in Cupertino Union School District head on, with heart. I have worked tirelessly with the board for ALL of our 14,000 students to: 1) ensure every learner and staff member can safely engage in the high-quality education that CUSD is renowned for, 2) put an end to kicking the can down the road on urgent enrollment and budgetary issues plaguing the district for years, and 3) restore and protect fiscal stability for CUSD so that we may move forward keenly focused on our students, teaching, and learning. We are better than the outrageous false claims and polarizing rhetoric in the Recall Petition above. Our students always come first—none of our board serves this community for any other reason. The last thing CUSD needs is a forced and costly special election just a few short months before the next regular election.
